AMENDMENT OF THE REGULATIONS MADE UNDER THE JUDGES' REMUNERATION ACT, 1990

Under the powers vested in me by section 5 of the Judges' Remuneration Act, 1990 (Act No. 18 of 1990), and after consultation with the Judicial Service Commission, I have made the regulations set out in the Schedule, with effect from 1 April 2014.

SCHEDULE

Definitions

1. In this Schedule, the regulations means the Regulations published in Government Notice No. 107 of 30 May of 2003 as amended by Government Notice No. 12 of 29 April 2005.

Amendment of regulation 5 of the Regulations

2. Regulation 5 of the Regulations is amended by the addition after subregulation (6) of the following subregulation:

“(7) A-

- (a) furniture allowance, equivalent to the furniture allowance payable to the Speaker, is payable to the Chief Justice; and
- (b) furniture allowance, equivalent to the furniture allowance payable to a Minister, is payable to the Judge-President.”.

AMENDMENT OF SECOND SCHEDULE TO JUDGES' REMUNERATION ACT, 1990

Under the powers vested in me by section 3 of the Judges' Remuneration Act, 1990 (Act No. 18 of 1990), and on the recommendation of the Judicial Service Commission, I substitute the following Schedule for the Second Schedule to that Act, with effect from 1 April 2014.

| Designation of Office | Salary per annum |
|-----------------------------------|--|
| Chief Justice | 1 021 402 |
| Supreme Court Judge | 990 452 |
| Supreme Court <i>ad hoc</i> Judge | Salary equal to that of Supreme Court Judge, proportionate to the period during which he or she acts as <i>ad hoc</i> Judge. |
| Judge-President | 974 975 |
| High Court Judge | 928 548 |
| High Court Acting Judge | Salary equal to that of High Court Judge, proportionate to the period during which he or she acts as Acting Judge. |
